

3 WHEREAS, Lions Clubs have distinguished themselves in providing
4 community-based charitable works for almost 80 years, under the simple
5 slogan, "We Serve"; and

6 WHEREAS, the Guam Latte Stone Lions Club of District 204 is
7 sponsoring the creation of a new Lion's Clubs International affiliate club on
8 Guam, to be known as "Guam Sprit Lions Club"; and

1 **WHEREAS**, Guam Spirit Lions Club is being chartered as Lions Clubs
2 International Number 97421 on October 28, 2006; and

3 **WHEREAS**, the 29 charter members of the Guam Spirit Lions Club have
4 specifically identified “Educational and Cultural Enrichment for the Youth” as
5 a community need, worthy of their priority attention and dedicated effort as
6 their Club project; and

7 **WHEREAS**, organizing and leading the members of any group requires
8 special leadership skills recognized by members of the group, to ensure that
9 their dedication of individual time and talent achieves a common goal and
10 common fulfillment of purpose; and

11 **WHEREAS**, Lions Clubs utilize the wisdom and enthusiasm of
12 experienced members, known as a “Guiding Lion” to closely guide other
13 Lions’ volunteer activities towards accomplishment of their project activities;
14 and

15 **WHEREAS**, Ms. Bernie S. Manglona has offered her services as a
16 “Guiding Lion” to the other Charter Members and Charter Officers of Guam
17 Spirit Lions Club, at this inaugural moment in their Club’s legacy; and

18 **WHEREAS**, Ms. Bernie S. Manglona will be officially installed and
19 assume her duties as a Guiding Lion of the Guam Spirit Lions Club District
20 204 at its Charter Meeting, to be held on October 28, 2006 in the Pandanus
21 Ballroom, Guam Reef Hotel; now, therefore, be it
