WHEREAS, Mr. Henry Sy, Sr. created Shoe Mart in 1958 when the owner and Chairman of the Board opened its doors at the lowly streets of Rizal Avenue in downtown Manila, Philippines; and

WHEREAS, Shoe Mart pioneered in the latest fashion trends of shoes and bags, presented in a distinct scheme comparable the best department stores throughout the world; and

WHEREAS, with the success of Shoe Mart in Rizal Avenue, several stores were opened in Carriedo and Tabora (Divisoria) in the 1960's and expanded a ready-to-wear apparel and accessories in Quiapo in 1972; and
