BE IT RESOLVED BY I MINA' BENTE OCHO NA LIHESLATURAN GUÅHAN:

WHEREAS, Mr. and Mrs. Roman L.G. and Maria "Mae" Cruz Quinata were married on October 22, 1955; and

WHEREAS, Mr. and Mrs. Roman L.G. and Maria "Mae" Cruz Quinata have been blessed with four children: *Roman* and *Annie Pereda Quinata*, *Josephine "Terry" Quinata* and *Michael Doyle*, *Francis "Frank"* and *Pamela Sgambelluri Quinata*, and *Senator John "JQ"* and *Donna Muna Quinata*; and both are also the proud grandparents of their eleven (11) grandchildren and seven (7) great grandchildren; and

WHEREAS, as a married couple and active members of our community, Mr. and Mrs. Roman and Maria “Mae” Cruz Quinata have and continue to contribute towards the prosperous growth of our Island; and

WHEREAS, Mr. Roman L.G. Quinata’s service to our Island Community began when he served as an Advisor to the Local Chapter of the Boy Scouts of America and later joined the Guam Militia; and

WHEREAS, after serving three (3) years in the United States Army during the Korean War and after working as a Power Plant Electrician with the U.S. Naval Public Works Center in Guam, Mr. Quinata was elected by the residents of the Municipality of Talofofo to serve as their Commissioner for three (3) consecutive terms beginning in 1968; and

WHEREAS, as the Commissioner of Talofofo, Mr. Quinata was instrumental in the implementation of one of Guam’s first postal mail delivery system and in organizing a variety of activities for the youth, many of which included sports such as basketball, football, and little-league baseball; and

WHEREAS, Mr. Quinata then worked for the Public Utilities Agency of Guam (PUAG) as a Utilities Consultant, where he would retire after more than thirty-three (33) years of combined service in different government of Guam entities, and where he later served as a member of new Guam Waterworks Authority’s Board of Directors; and

WHEREAS, Mr. Quinata’s loving wife and lifelong partner, Mrs. Maria “Mae” Cruz Quinata, began her career as an Accountant with the Pacific

Construction Company (PCC), where she would leave the private sector as an Office Manager for the company; and

WHEREAS, Mrs. Maria “Mae” Cruz Quinata entered government service as an Accountant with the Department of Corrections, and shortly after, she was employed at the Department of Public Health and Social Services as the agency’s Comptroller; and

WHEREAS, Mrs. Quinata then worked for the Department of Labor, where she would retire after more than twenty-five (25) years of combined service in different government of Guam entities, with the next seven years devoted to serving as a member of Guam Environmental Protection Agency’s Board of Directors from 1994 thru 2001; and

WHEREAS, throughout her marriage, Mrs. Quinata has and continues to be active in a variety of charitable and religious organizations, serving as a member of the Christian Mothers’ Associations in the Municipalities of Inarajan and Talofofo; member of the Guam Memorial Hospital Volunteers Association since 1995 (currently serving as President); member of the Island Board of Christian Mothers; and as Regent of the Catholic Daughters of the Americas, Court 2047, Our Lady of Camarin, for two terms; and

WHEREAS, throughout their fifty (50) years of marriage and in both their personal and professional lives, Mr. and Mrs. Roman L.G. and Maria “Mae” Cruz Quinata have assiduously stressed integrity and respect for others and both have served as a source of inspiration to their colleagues, friends, and family, to

whom they have always encouraged spiritual, personal, and professional growth; and

WHEREAS, as people who have and continue to devote their lives to nurturing a caring and loving family, Mr. and Mrs. Roman L.G. and Maria “Mae” Cruz Quinata have also spent much of their time actively helping the people of Guam through their contributions in numerous civic, community, and religious activities; and, now therefore, be it
