6 **Filipino entrepreneurs on Guam, from December 8 to December 16, 2007; and**


1 **WHEREAS**, the Filipino Food Festival will showcase the culinary

9 now, therefore, be it


1 **RESOLVED**, that the Executive Committee of *I Mina'Bente Nuebi Na*
