10 which will outline the Port's expansion and major development projects over  
11 the next decades; and

15           **WHEREAS**, through Mr. Tagawa's direction, the Jose D. Leon Guerrero

20 Manager of the Port for personal and health reasons; and


21           **WHEREAS**, Mr. Tagawa is not only an outstanding General Manager
