**Relative to recognizing the contributions to Guam made by Mr. Manfred Pieper during his second term as General Manager, Hilton Guam Resort & Spa, and bidding him 'Best Wishes and *Buen Viaje*' as he assumes his new position as General Manager of the Conrad Bangkok in Thailand.**

1        **BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I**  
2        ***MINA'BENTE NUEBI NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS,** after being named General Manager of the Hilton Guam  
4        Resort & Spa in January 1988 and promoted in 1995 to Vice President for East  
5        Asia and Thailand, while simultaneously maintaining his General Manager

1 role at the Hilton Guam Resort & Spa, Mr. Manfred Pieper left Guam to take  
2 the position of General Manager of Hilton Tokyo in Japan in 1998; and

3 **WHEREAS**, for personal reasons Mr. Pieper and his wife Li Wei  
4 returned to their adopted home, Guam, in 2000 where he began a second term  
5 as General Manager of the Hilton Guam Resort & Spa; and

6 **WHEREAS**, aside from his duties as General Manager, Mr. Pieper  
7 became involved once again in local civic activities as Chairman of the Boy  
8 Scouts of America's fundraising campaign 2003, serving on the Guam  
9 Community College Foundation and Trust, sitting as a member of the Board  
10 of Directors of the Guam Chamber of Commerce, and is a board member of  
11 the American Red Cross and served as the Chairman of the '4<sup>th</sup> Annual Red  
12 Ball' fundraising committee; and

13 **WHEREAS**, from 2000 through 2001, Mr. Pieper was selected as  
14 Chairman of the Board for the Guam Hotel & Restaurant Association,  
15 continuing a role that he had previously held from 1989 through 1994; and

16 **WHEREAS**, Mr. Pieper's managerial ability was recognized by a panel  
17 of his peers to be amongst the best on Guam as he was selected to be the  
18 Guam Business News 'Executive of the Year for 2001'; and

19 **WHEREAS**, he continued to offer his insights into making Guam a  
20 quality visitor destination as an elected member of the Guam Visitors Bureau  
21 Board of Directors, serving multiple terms from 1991 to 1995 and last serving  
22 from January 2005 through December 2006, and chairing the Market Research  
23 & Development Committee and the Tourism Industry Relations Committee;

1           **WHEREAS**, he has been the driving force behind the re-introduction to  
2 Guam of the Guam International Tennis Open, allowing him more time to  
3 pursue and enjoy one of the passions in his life - - tennis; and


4           **WHEREAS**, in his leisure time, Mr. Pieper is a member of the Rotary  
5 Club of Tumon Bay and the SKAL Club of Guam; now, therefore, be it

7 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the  
8 people of Guam, recognize the contributions to Guam made by Mr. Manfred  
9 Pieper during his second term as General Manager, Hilton Guam Resort &  
10 Spa; and be it further

11           **RESOLVED**, that the Executive Committee of *I Mina'Bente Nuebi Na*  
12 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the

14 Pieper as he departs Guam to assume his next post as General Manager of the  
15 Conrad Bangkok in Thailand; and be it further


16           **RESOLVED**, that the Speaker and the Chairperson of the Executive
