3 **WHEREAS, Mrs. Dora I. Flores was born on Guam on October 12, 1964**
4 **and currently resides in Afame, Sinajana. She is the daughter of Mr. Antonio**
5 **Duenas (deceased) and Concepcion San Nicolas Iriarte and is one of ten (10)**

1 siblings. She is the wife of Mr. Roque Flores and the proud mother of John
2 Jacob Iriarte; and

3 **WHEREAS**, Mrs. Flores graduated from George Washington High
4 School in 1981 and shortly thereafter began her career with the Government of
5 Guam as a temporary auxiliary employee with the Department of Public
6 Works; and

7 **WHEREAS**, Mrs. Flores transferred to the Guam Police Department on
8 November 19, 1984 and held the position of Payroll Clerk II fulfilling duties
9 such as Officer-in-Charge of Payroll Unit and assisting with the local budget
10 and financing, including federal grants; and

11 **WHEREAS**, from March 1994 to present, Mrs. Flores has been an
12 Administrative Assistant, which increased her responsibilities to include the
13 supervision of supply section and procurement; and


14 **WHEREAS**, aside from excelling as an Administrative Assistant, Mrs.
15 Flores continues to improve her expertise through training and workshops
16 such as Word Processing Program, Records Management Workshop, CPR,
17 Intro to DataBase III, Capital Budgeting, Intro to Spreadsheets, Advance
18 Spreadsheets, Fixed Asset Accounting, Management Accountability &
19 Control, Cost Accounting for Performance Budgeting, Life Savers Conference,
20 1st Annual Payroll Association Conference, Customer Service and Telephone
21 Skills & Team Building, Energy Compliance Official Conference, and
22 Weapons of Mass Destruction Training; and

1 **WHEREAS**, Mrs. Flores has received several awards, including “Civilian
2 Employee of the Year for 1992”, “1998 Governor’s Magnificent 7 Award of
3 Excellence – Female Athlete of the Year”, and the “2006 Governor’s MagHope
