President Joseph 9 Husslein, TakeCare Insurance Company, Inc. renews its commitment with a 10 Two Hundred Thousand Dollars (\$200,000) donation to the Nursing Program 11 for the year 2007. TakeCare Insurance Company, Inc. support of the 12 University of Guam's Nursing Program has enabled the program to obtain 13 necessary equipment and supplies, scholarships, and faculty development 14 that otherwise, given the current state of scarce resources, the University 15 would find difficult to fund. An increase in enrollment at both the nursing 16 and pre-nursing levels can be attributed in part to the investments made by 17 TakeCare in our Nursing Program; and 18 WHEREAS, the number of nursing majors has grown from eighty (80) in 2001 to one hundred fourteen (114) for spring 2007. Students enrolled in 19 20 the pre-nursing track have increased from two hundred seventy-five (275) in the Fall of 2004 to three hundred thirty-five (335) for Spring 2007. Twenty-21 22 eight (28) students will graduate with their nursing degrees on May 27th during the University's Spring 2007 commencement ceremonies; now, 23 therefore, be it 24
