17 Peace Officer; and Fred Panaguigon, Peace Officer; and


18 **WHEREAS**, the Iloilo Association of Guam will likewise induct the Board

25 people of Guam, thank the Iloilo Association of Guam for their contributions


1 to our island community and congratulate them on seventeen (17) years of
