3 **WHEREAS, Mr. Kenneth T. Tagawa was appointed by the Port Board of**
4 **Directors as General Manager effective July 1, 2007; and**

5 **WHEREAS, upon his employment with the Authority, Mr. Tagawa diligently**
6 **worked to provide the foundation in planning for the increase of military cargo from**
7 **the transfer of military forces from Okinawa to Guam: and**

8 **WHEREAS, through Mr. Tagawa's guidance, the Port Authority of Guam**
9 **entered into the final phase of the Port Master Plan, which will outline the Port's**
10 **expansion and major development projects over the next decades; and**

11 **WHEREAS, through Mr. Tagawa's leadership, the employees stepped up to**
12 **the challenge and worked to improve services by utilizing its current resources; and**

13 **WHEREAS, through Mr. Tagawa's direction, the Authority's public image**
14 **improved and he has successfully addressed the military's concerns that the Port could**

2 personal and health reasons; and

3 **WHEREAS**, Mr. Tagawa is not only an outstanding general manager who
4 willingly devotes all his time and energy to the Port but is also a quiet and firm father
5 to the Port employees who inspires them to strive for excellence; now therefore be it
