WHEREAS, Mrs. Flores graduated from George Washington High School in 1981 and shortly thereafter began her career with the Government of Guam as a temporary auxiliary employee with the Department of Public Works; and

WHEREAS, Mrs. Flores made the transition to the Guam Police Department on November 19, 1984 and held the position of Payroll Clerk II fulfilling duties such as Officer in Charge of Payroll Unit and assisted in

any administrative services with the processing of local budget and financing which was inclusive of federal grants; and

WHEREAS, from March 1994 to present, Mrs. Flores made jump to Administrative Assistant which increased her responsibilities to include the supervision of supply section and procurement; and

WHEREAS, aside from excelling in her duties as Administrative Assistant within GPD, Mrs. Flores continues to improve her expertise through additional trainings and workshops such as Word Processing Program; Records Management Workshop, CPR, Intro to dBase III, Capital Budgeting, Intro to Spreadsheets, Advance Spreadsheets, Fixed Asset Accounting, Management Accountability & Control, Cost Accounting for Performance Budgeting, Life Savers Conference, 1st Annual Payroll Association Conference, Customer Service and Telephone Skills & Team Building, Energy Compliance Official Conference, Weapons of Mass Destruction Training's; and

WHEREAS, her hard work and dedication has not been without notice for throughout her career, Mrs. Flores has received several awards including Civilian Employee of the Year for 1992, 1998 Governor's Magnificent 7 Award of Excellence – Female Athlete of the Year, and the 2006 Governor's MagHope Award of Excellence – Supervisor of the Year; now, therefore, be it
