Relative to commending and congratulating Connie and Bill Nielson and the success of their franchise, Guam Harley-Davidson, on their Seventh (7th) Anniversary.

1 BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I
2 *MINA'BENTE NUEBI NA LIHESLATURAN GUÁHAN*:

3 WHEREAS, Harley-Davidson, Inc. was founded in 1903 and is based in
4 Milwaukee, Wisconsin. Harley-Davidson is one of only two mass producers
5 of American motorcycles. A favorite of motorcycle enthusiasts, Harleys are
6 also used by many police forces; and

7 WHEREAS, through their hard work, dedication, and love of Harleys,
8 Connie and Bill Nielson brought Harley-Davidson to Guam, allowing our
9 people to share in this American legend; and

10 WHEREAS, in 2001, Connie and Bill Nielson, a Harley enthusiasts
11 themselves, started selling a handful of Harley-Davidson motorcycles out of
12 their warehouse, where Bill Nielson was running his primary company,
13 Pacific Technical Services; and

1 **WHEREAS**, in 2002, Connie and Bill Nielson expanded their business in
2 dealing Harley-Davidson products, selling 80 bikes and opening their first
3 store in the Micronesian Mall in a 900 sq. ft. location; and

4 **WHEREAS**, in 2003, Connie and Bill Nielson enhanced their operation
5 to a 2,000 sq. ft. store, and continued marketing the Harley-Davidson brand
6 throughout the island, including the sale of 140 bikes that year; and

7 **WHEREAS**, the success of Guam Harley-Davidson is further evidenced
8 by the opening of the newest store location in Asan, in a building known as
9 the local landmark, "Joe's & Flo's"; and

10 **WHEREAS**, Connie and Bill Nielson have marketed Harley-Davidson to
11 such a level, opening up the pastime of motorcycling to people of all walks of
12 life, thus earning the admiration and appreciation of the people of Guam ;
13 now, therefore, be it

14 **RESOLVED**, that the Executive Committee of *I Mina'Bente Nuebi Na*
15 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
16 people of Guam, thank Connie and Bill Nielson of Guam Harley-Davidson for
17 their contributions to our island community; and be it further

18 **RESOLVED**, that the Speaker and the Chairman of the Executive
19 Committee certify, and the Secretary of the Legislature attest to, the adoption
20 hereof, and that copies of the same be thereafter transmitted to Mr. Bill
21 Nielson; and to the Honorable Felix P. Camacho, *I Maga'lahaen Guåhan*.
