Subject: Capitol District Fund

Dear Governor Calvo:

I am in receipt of a copy of your letter, which is dated January 16, 2016, and addressed to Public Auditor Doris Flores Brooks requesting her to conduct a forensic audit of the Capitol District Fund. According to your letter, your concern is relative to two transactions made out of this fund, specifically:

- 1. January 29, 2013 in the amount of \$431,000
- 2. January 7, 2015 in the amount of \$330,965

I would like to reiterate that since the establishment of the Capitol District Fund, there were only two transfers out of this fund, and both of these transfers were made pursuant to P.L. 31-285. I would also like to reiterate that both of these transfers out of the Capitol District Fund were reimbursed with real cash resulting from the appropriations of \$431,000 and \$330,965 made in P.L. 32-068 and P.L. 32-181, respectively.

Although we have provided this information to your staff on numerous occasions, it remains unfortunate that the same questions are being asked of us, over and over, to include a barrage of continued unfounded allegations made by you and your staff that the Legislature's handling of the Capitol District Fund is fraught with illegal activity. There has been absolutely no determination by the Attorney General that any activity regarding the Capitol District Fund is suspicious. Interestingly, your public attacks and slanderous allegations against myself and the Legislature as a whole occurred after the Attorney General of Guam determined that the retroactive payments given to your Adelup staffers were in fact illegal. Quite contrary to your actions, Vice Speaker Cruz was very cautious and thorough when he initially questioned the 107 Adelup payments

- 1. Bank Statements from October 31, 2008 through December 31, 2015;
- 2. Public Law establishing Capitol District Fund (P.L. 29-69, signed on April 29, 2008);
- 3. P.L. 31-285 signed January 18, 2018 (Authorizing transfer of \$431,000 and \$330,965 to pay for prior year obligations);
- 4. P.L. 32-68 signed on September 11, 2013 (Reimbursement of \$431,000 to the Capitol District Fund);
- 5. P.L. 32-181 signed on September 5, 2014 (Reimbursement of \$330,965 to the Capitol District Fund);
- 6. Two Fund Transfer Documents (\$431,000 and \$330,965); and
- 7. Allotment Schedule and Bank Deposits showing \$431,000 and \$330,965 were deposited into the Capitol District Fund

In addition to providing these documents, we are also respectfully requesting that you expedite this forensic audit as quickly as possible so that this issue, which has been purely fabricated by Governor Calvo and his staff, does not leave a dark cloud over the Legislature during the upcoming elections as clearly this entire matter is politically motive by Governor Calvo.

I am in receipt of a copy of Governor Eddie Calvo's letter, which is dated January 16, 2016, and addressed to you requesting the Office of Public Accountability to conduct a forensic audit of the Capitol District Fund. According to Governor Calvo's letter, his concern is relative to two transactions made out of this fund, specifically:

- 1. January 29, 2013 in the amount of \$431,000
- 2. January 7, 2015 in the amount of \$330,965

I would like to reiterate that since the establishment of the Capitol District Fund, there were only two transfers out of this fund, and both of these transfers were made pursuant to P.L. 31-285. I would also like to reiterate that both of these transfers out of the Capitol District Fund were reimbursed with real cash resulting from the appropriations of \$431,000 and \$330,965 made in P.L. 32-068 and P.L. 32-181, respectively.

We are grateful that you have agreed to conduct this forensic audit and we welcome your review of all transactions. Just this afternoon we met with officials from your office and provided them with the following documents:

- 1. Bank Statements from October 31, 2008 through December 31, 2015;
- 2. Public Law establishing Capitol District Fund (P.L. 29-69, signed on April 29, 2008);
- 3. P.L. 31-285 signed January 18, 2018 (Authorizing transfer of \$431,000 and \$330,965 to pay for prior year obligations);
- 4. P.L. 32-68 signed on September 11, 2013 (Reimbursement of \$431,000 to the Capitol District Fund);
- 5. P.L. 32-181 signed on September 5, 2014 (Reimbursement of \$330,965 to the Capitol District Fund);

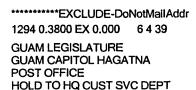

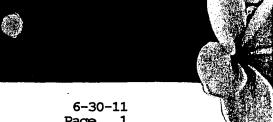

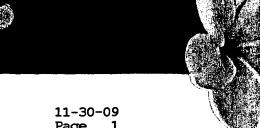

Transmitted herewith is Bill No. 269(EC), "AN ACT TO AMEND CERTAIN PROVISIONS OF CHAPTER 58 OF TITLE 5 OF THE GUAM CODE ANNOTATED, RELATIVE TO THE FINANCING AND CONSTRUCTION OF EDUCATION FACILITIES" which I signed into law on April 29, 2008 as **Public Law 29-69.**

I would like to thank you and *I Mina' Bente Nuebi Na Liheslaturan Guahan* for the expeditious enactment of my proposed measure to provide for the financing and procuring of the requisite collateral equipment for the new schools to open for the 2008-2009 school year.

However, the version that was enacted inserted a provision, Distribution of Proceeds, to the original measure that would allocate and disburse the bond proceeds to go towards payment of the bond. Bond Counsel would not be able to approve a transaction in which proceeds of the sale of certificates of participation would be used to pay costs of issuance or make a deposit into a reserve of any type, including the Certificate Debt Service Reserve Fund.

Although not required, Bond Counsel recommends the following technical amendment to lead-in to Section 6 of the Bill as follows: "The Guam Education Financing Foundation shall allocate and disburse the <u>net</u> proceeds received pursuant to this Act, <u>after payment of financing costs and deposits into required reserves</u>, according to the following priorities:" The rest of Section 6 is fine.

Bond Counsel has also recommended another technical amendment to change the definition of collateral equipment in Section 7 of the Bill to mean "items having an <u>economic useful life</u> of three years or longer" which is more appropriate than "shelf life".

Again, I respectfully request your immediate action to make these necessary technical amendments in order to ensure that the new schools will have the collateral equipment for the start of the new school year 2008-2009.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that pursuant to the Education Construction Initiative Act of 2005, the government of Guam executed a municipal lease to construct four (4) new schools and convert an elementary school to a middle school. The construction of the schools is nearing completion and could open for the 2008-2009 school year.

I Liheslaturan Guåhan further finds that the budget for the Guam Public School System (GPSS) does not include the necessary appropriation to procure collateral equipment for the schools. GPSS is seeking assistance to fund this equipment in order for the schools to be ready to open for the 2008-2009 school year. Notwithstanding the government's procurement process, I Liheslaturan Guåhan finds that it is estimated to take approximately twenty (20) weeks to order and deliver the collateral material.

In order to assist GPSS, *I Maga'lahen Guåhan* has committed an additional One Million Dollars (\$1,000,000) of Guam's allocation of Compact Impact Funds

Section 7. Collateral Equipment. For the purpose of this Act, Collateral Equipment shall mean items having a shelf life of three (3) years or longer.

Section 8. Financing instruments, as amended by this Act, shall have a final maturity date not later than six (6) years after their date of issuance, and bear interest at such rate and shall be sold for such price or prices as shall result in a yield to the holders of such instruments not exceeding seven and one-half percent (7.5%) per annum.

Section 9. §79601 of Title 21, Guam Code Annotated, is hereby *amended* to read:

"§79601. Creation of Guam Capitol District. The Guam Capitol District is hereby established, consisting of the grounds and structures comprising the old Guam Congress Building (the old legislative building), Skinner Plaza, Plaza de Espana, the Manuel F.L.Guerrero Administration Building and, upon the termination or expiration of any leases attached to the property, the Post Office in Hagatña. Properties included in the Guam Capitol are hereby placed under the control and supervision of I Liheslaturan Guåhan. This Section shall not be interpreted as preventing the development and beautification of Skinner Plaza, as detailed in the Budget Act for Fiscal Year 1998. Government agencies and departments utilizing facilities in the Guam Capitol District shall continue to do so unless subsequently and otherwise indicated by I Liheslaturan Guåhan. The Department of Parks and Recreation, the Department of Public Works and other government agencies that may provide maintenance, security and other services on property within the Guam Capitol District shall continue to do so unless subsequently and otherwise indicated by the Guam Legislature. The provisions of other Sections of this Act do not apply to the Guam Capitol District. Notwithstanding any other provision of law, The Speaker of I Liheslaturan Guåhan may be authorized by Legislative Resolution passed by two thirds (2/3) vote of the Members to negotiate, approve, and execute lease agreements for the premises of the Agana Post Office to the United States Postal Service in one (1) year increments, terminable by I Liheslatura upon no more than one hundred twenty (120) days notice. Leases of property within the Capitol District shall be procured pursuant to procurement laws applicable to I Liheslatura, and shall be approved as to form by Legislative Counsel."

Section 10. A new §79601.1 is *added* to Title 21, Guam Code Annotated, to read:

"Capitol District Fund. Income received pursuant to any lease of property within the Capitol District, shall be deposited to the Capitol District Fund, which is hereby created as a special fund of the government of Guam and shall not be commingled with any other fund of the government of Guam nor subject to transfer by I Maga'lahi. The Capitol District Fund shall be under the exclusive purview and control of I Liheslatura and shall be dedicated and used solely for the repair, restoration, renovation, or refurbishment of the Guam Congress Building or other Capitol District properties in compliance with the Capitol District law (§79601, Title 21, GCA), with I Liheng Para Sagan I Liheslaturan Guåhan (§1126, Title 2, GCA), and the historical preservation laws of Guam. Expenditure from the Capitol District Fund shall be pursuant to Legislative Resolution and shall not be used for operations."

Section 11. Section 2 of P.L. 29-04, as amended by P.L. 29-52:12, is hereby amended as follows:

"Section 2. Fund Authorized for COLA Settlement Payment. The promissory note for Ten Million Dollars (\$10,000,000) plus interest and any

§ 79601.2. War on Terror Fallen Heroes Monument.

Notwithstanding any other provision of law, the Fallen Heroes of the Pacific Foundation (Guam) is hereby authorized to erect a memorial monument in the Skinner Plaza, Hagatia, in honor of the ultimate service and sacrifices of the men and women who have served in the US. Armed Forces in the War on Terror, to include Operation Iraqi Freedom and Operation Enduring Freedom.

The Fallen Heroes of the Pacific Foundation in the preparation and construction of the War on Terror Fallen Heroes Monument shall comply with the following provisions:

- (a) occupy a land space not to exceed more than twenty feet (20') in length and twenty feet (20') in width within the northern segment of Skinner Plaza;
- (b) submit to *I Liheslaturan Guåhan* the plan and design of the monument for legislative approval by statute or resolution. The monument shall include, at a minimum and as provided for in this Chapter, the names of Guam's fallen heroes and the branch served in the U.S. Armed Forces; and
- (c) shall not hold the government of Guam liable or responsible for any expenses related to the construction and maintenance of the monument authorized herein.

- (2) Three-fourths day (6 hours) for each full bi-weekly pay period in the case of employees with five (5) years of service, but *less than* fifteen (15) years of service.
- (3) One (1) day (8 hours) for each full bi-weekly pay period in the case of employees with fifteen (15) years or more of service.

For purposes of this Subsection (a), all elected officials, except members of the Guam Education Board, the Governor and Lieutenant Governor, Members of *I Liheslaturan Guåhan*, and the Consolidated Commission on Utilities, shall be deemed employees occupying permanent positions."

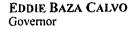

- (b) No retiree who is eligible for retiree supplemental annuity benefits provided for in Subsection (a) shall receive said benefits if her or his annual retirement annuity, excluding survivor benefits and excluding the supplemental benefits authorized herein, is greater than Forty Thousand Dollars (\$40,000). No retiree who is eligible for retiree supplemental annuity benefits shall receive more than the sum of Forty Thousand Dollars (\$40,000) in combined retirement annuities and supplemental annuity benefits in any one (1) fiscal year.
- (c) The Director of DOA *shall* coordinate with the Director of the Government of Guam Retirement Fund (GGRF) and *shall* disburse to the retirees, or their survivors, the supplemental annuity benefits provided for in Subsection (a) of this Section. The GGRF *shall* provide the Director of DOA with the information needed to affect disbursement. To realize savings

(a) I Maga'lahen Guåhan shall provide, by a single lump sum payment, a Cost of Living Allowance (COLA) of Two Thousand Dollars (\$2,000) to each retiree of the GGRF who is retired as of September 30, 2014, or his survivor, no later than November 1, 2014. The sum of Twelve Million Nine Hundred Seventy Seven Thousand Three Hundred Thirty Four Dollars (\$12,977,334) is appropriated from the General Fund to the DOA to pay said COLA.

- (b) The Guam Power Authority, the A.B. Won Pat International Airport Authority, the Guam Economic Development Authority, the Guam Housing Corporation, the Government of Guam Retirement Fund, the Jose D. Leon Guerrero Commercial Port, the Guam Waterworks Authority, and the Guam Visitors Bureau *shall* pay a COLA in a single payment of Two Thousand Dollars (\$2,000) to every Government of Guam Retirement Fund retiree who retired from each respective aforementioned agency as of September 30, 2014, or his survivor, *no later than* November 1, 2014.
- (c) Each agency mentioned in Subsection (b) *shall* reimburse the General Fund for any COLA paid by the General Fund in Fiscal Year 2015 to retirees who have retired from that agency and their survivors, *no later than* December 31, 2014.
- (d) Any retiree or survivor eligible to receive the COLA may waive their payment authorized herein by filing a notarized affidavit waiving such payment with the entity responsible for the Retirement Fund.
- (e) If a retiree is both a Defined Benefit and a Defined Contribution Retiree, her or his survivor *shall only* be entitled to a single COLA payment.
- Section 6. Appropriation to the Capitol District Fund. The sum of Three Hundred Thirty Thousand Nine Hundred Sixty Five Dollars (\$330,965) is appropriated from the General Fund to *I Liheslaturan Guåhan* for the Capitol

District Fund for Fiscal Year 2015, and *shall not* be used for any operational expenditures.

3 Retiree Medical, Dental and Life Insurance Expenses Section 7. Appropriated to the Government of Guam Retirement Fund (GGRF). The 4 5 sum of Fourteen Million Two Hundred Eighty Seven Thousand Three Hundred 6 Ten Dollars (\$14,287,310) is appropriated from the General Fund, Five Million 7 Four Hundred Sixty Nine Thousand Seven Hundred Seventy Dollars (\$5,469,770) 8 is appropriated from the Section 2718 Fund, and Two Million Four Hundred Fifty 9 Thousand Six Hundred Seventy Two Dollars (\$2,450,672) is appropriated from the 10 unappropriated fund balance of the Section 2718 Fund to the GGRF to pay for 11 retiree group medical and dental insurance premiums and life insurance subsidy, 12 including retiree group medical and dental insurance premiums and coverage and 13 life insurance subsidy for Judiciary of Guam retirees, to continue existing 14 programs currently contained in the semi-monthly payments. The appropriation from the unappropriated fund balance of the Section 2718 Fund in this Section 15 shall continue to be available until fully expended. 16
