

The Bureau requests that Bill No(s) 404-30(COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 404-30(COR) appears to be administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.

Please note that there seems to be a misreading on Bill No. 404-30(COR). Section 2 of the bill repeals Section 80106 "Comprehensive Zoning Plan" in its entirety and Section 3 intends to add a new Section 80106, however incorrectly identifies "Section 80105 Ancestral Lands Zoned Agriculture". Section 80105 is relative to the Transfer of Property to the Guam Ancestral Lands Commission.
