

Comments:

1/ There is a potential for additional revenues as Section 4 of Bill No. 447-30 (LS) provides for the I Maga'lahen Guahan to enter into a lease agreement for a portion of Lot No. 10142 New PTN Tract 100, also known as the Dededo Sports Complex.

The estimated total revenues to be collected is undetermined at this time as it is dependent on information not available such as the lease rental amount based on the fair market value of the intended use and covenants of the property.

THE ESTIMATED TOTAL REVENUES TO BE COLLECTED IS UNDETERMINED AT THIS TIME AS IT IS DEPENDENT ON INFORMATION NOT AVAILABLE SUCH AS THE LEASE RENTAL AMOUNT BASED ON THE FAIR MARKET VALUE OF THE INTENDED USE AND COVENANTS OF THE PROPERTY.
