Footnotes:
Bill 374-31 (COR) proposes to create a Department Psychologist position within the Guam Police Department (GPD). The bill does not provide for funds to cover the cost of the proposed position for FY2012. The bill requires GPD, the Department of Administration and the Bureau of Budget and Management Research to formulate and adopt a commensurate salary for the position. The Government of Guam's Position Listing includes a Psychologist position at Pay Grade P with a salary range of \$36,850 - \$77,969. However, in its present form, the fiscal impact can not be determined with the requirement for the three (3) departments to adopt a commensurate salary for this position.


