1/ The Bill has a potential for additional funding impact on DOC in terms of establishing an International Prison Transfer Program and a designation of an administrator to oversee the whole program and other operational expenses, however in its present form that impact cannot be determined at this time. This program will help DOC with overcrowding in the facilities and reduce over head costs in the
