1/ The Bill has a potential fiscal impact that may prove to be positive in the availability and utilization of Government of Guam local funds. The Bill which proposes to give authorization for the Mayors' Council of Guam to solicit monetary and in-kind contributions to help defray the cost of the Mayors' oath of office ceremony will be be a cost saving measure of at least \$25,000 in local funds on an annual basis. Such funds may be reallocated to other GovGuam agency program needs. However, in its present form, such impact cannot be determined at this time.
