The Bureau requests that Bill No(s). 525-31 COR be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

The Bill is administrative in nature. The intent is to require mammography reporting requirements for specific patients with dense breast tissue. The proposed measure will require the health facility at which mammography examinations are performed to include in the written summary of the report to the patient, a notification that the patient should consider digital mammography as it has been shown to be more effective in early detection of breast cancer in women with dense breast tissue.
