The Bureau requests that Bill No(s). 325-31 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

The Bill adds a new § 3329.1 to Chapter 3 of Title 16 Guam Code Annotated relative to providing for the safety of the visually impaired when crossing Guam roadways, and stipulating that any driver who fails to take such precaution shall be liable in damages for any injury caused such pedestrians. The intent is administrative in nature as submitted for legislative consideration, and does not impact any government funds of the Government of Guam.
