Comments:

1/ There is a potential for additional revenues to the Government of Guam in terms of real property and income taxes upon rezoning of Lot No. 3261-1-R3, in the municipality of Chalan Pago, from Residential "R-1" to Light Industrial "M1" zone since it would allow the property to be utilized in a similar manner or in support of neighboring existing enterprises.

The overall potential financial impact of the Bill, in its present form, cannot be determined at this time.
