The Bureau requests that Bill No. 337-31 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

It is the Legislature's intent to protect the Chamorro Land Trust lands from being used or abused in its development which will render such land inhabitable or unsuitable for use by the Trust's beneficiaries for the production of food sources or the use as shelter and homes. In view thereof, the Bill adds conditions that prohibit the issuance of any lease or license for any activity or development on any Chamorro Land Trust property that will not allow the use of property for agriculture or residential development upon the expiration or termination of such lease or license.

The provisions of the Bill are administrative in nature and its passage would not have a financial impact on the Government of Guam.
