The Bureau requests that Bill No. 102-32(COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 102-32(COR) is an Act to amend §4402 of Ch. 4, Title 4, GCA relative to meetings of the Civil Service Commission to include the provisions of deliberations. The amendment notes that CSC meetings will still be an open forum to the public *except* that any and all deliberations of the board may occur in a closed session with no requirement of transcription/recording of such deliberation. Deliberations can only be conducted in the presence of the Commission's Board Members, Legal Counsel, and Executive Director.

The intent of the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.

1 AN ACT TO AMEND §4402 OF CHAPTER 4, TITLE 4, GUAM
2 CODE ANNOTATED, RELATIVE TO THE MEETINGS OF THE
3 CIVIL SERVICE COMMISSION

4 BE IT ENACTED BY THE PEOPLE OF GUAM:

5 **Section 1.** Section §4402 of Chapter 4 of Title 4, Guam Code Annotated is
6 hereby *amended* to read:

7 **“§4402. Quorum and Deliberations**

8 The quorum of the Commission shall be four (4) members. Meetings
9 of the Commission shall be conducted in accordance with the Open
10 Government Law except that any and all deliberations of the Commission
11 may occur in a closed session and no transcript of such deliberation need be
12 maintained, nor shall the Commission be required to record such
13 deliberation. When conducting such closed deliberations, only members of
14 the Commission board, along with the Commission’s counsel and its
15 Executive Director may be present. No action may be taken by the
16 Commission during such closed deliberation and voting must occur in open
17 session. The affirmative vote of four (4) members shall be required for any
18 action of the Commission and such vote must be conducted in an open,
19 public meeting. The Commission may adopt rules to govern its procedures
20 and the standards maintained by non-attorney representatives; provided, that

1 rules adopted by the Commission shall recognize that representative is not
2 an attorney and cannot be bound by the same standards and ethics as an
3 attorney; and, further, provided, that in cases where an employee represents
4 oneself, the Commission shall render all possible assistance to the employee
5 to insure a fair and impartial hearing.”
