Bureau of Budget & Management Research Attachment to Fiscal Note No. <u>103-32 (COR)</u>

The proposed legislation is aimed at amending the current law regarding stipend payments for meeting served by board members of boards and commissions. Section 14 of Public Law 31-233 states that if a board member has served on a board continuously for ten (10) years or more, they may receive stipends totaling no more than Two Hundred Fifty Dollars (\$250) per month for meetings attended.

The Civil Service Commission currently has seven (7) board members receiving stipends at Fifty Dollars (\$50) per meeting. Out of the seven (7) board members, three (3) members have served for more than ten (10) years and receive stipends amounting to five (5) meetings per month (\$250 monthly stipend cap  $\div$  \$50 per meeting attended). CSC meetings are held twice every week, with a conditional third meeting depending on the severity of the case at hand (about 8-12 meetings per month).

If the proposed legislation is passed, the members who have served on the CSC board *will not be* subject to the Two Hundred Fifty (\$250) monthly stipend caps. The Bureau estimates that an additional \$150-\$350 per month/\$1,800-\$4,200 per year will be required for CSC to cover stipends for the three (3) board members who have served continuously for ten (10) or more years. There is sufficient funding this fiscal year to cover the projected stipends for the three (3) board commissioners.

# 1 AN ACT TO AMEND SECTION 14 OF CHAPTER XII, OF PUBLIE 2 LAW 31-233, RELATIVE TO THE STIPENDS OF THE CIVIL 3 SERVICE COMMISSION 4 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Section 14 of Chapter XII of Public Law 31-233 hereby *amen<u>ited</u>*to read:

"Section 14. Board and Commission Meeting Stipends. Any 7 compensation or stipend owed to a Board or Commission member for 8 attending a regular or special meeting in Fiscal Year 2013 shall be paid from 9 the budget of the department or agency responsible for the administrative 10 support and operations of such Boards or Commissions. *Except* for the Civil 11 Service Commission, any Boar-d member who has served on a Board 12 continuously for ten (10) years or more may receive a stipend totaling no 13 more than Two Hundred Fifty Dollars (\$250) per month for meetings 14 attended; however, Board and Commission members may elect to not 15 receive said compensation, I Maga'låhen Guåhan may by Executive Order, 16 waive the payment of meeting stipends owed to any Board or Commission 17 member." 18
