1/ This proposed legislation is aimed at transferring the title to/jurisdiction over the parcel of real property in the municipalities of Tiyan, Tamuning encompassing 4,091 square meters Lot No. 7 NEW, Block No. 1, Tract 1427 from the Guam International Airport Authority (GIAA) to the Chamorro Land Trust Commission (CLTC). The GIAA currently generates revenues on the said parcel of property in the form of lease payments for the operations of a restaurant facility. The transfer of said property and revenue generated through the lease will support mandates under the CLTC. If the proposed legislation is passed and the title to/jurisdiction over said property is transferred to the CLTC, the Bureau estimates that \$42,710.04 of yearly revenues and as much as \$213,550.20 for the first to fifth year will be received by the CLTC in the form of lease payments from the restaurant facility.

AN ACT RELATIVE TO TRANSFER OF THE TITLE OF OWNERSHIP OF LOT NO. 7 NEW, BLOCK NO. 1, TRACT 1427 LOCATED IN THE MUNICIPALITIES OF TAMUNING, TIYAN FROM THE GUAM INTERNATIONAL AIRPORT AUTHORITY TO THE CHAMORRO LAND TRUST COMMISSION.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslatura* finds that Lot No. 7
NEW, Block No. 1, Tract 1427, was transferred to the Guam International Airport
Authority (Airport) by the government of Guam for the development of industrial
operations directly related to airport operations.

After the transfer of this government property to the Airport, all lands not reserved for specific purposes were subsequently transferred to the Chamorro Land Trust (Trust) for its use in meeting the Trust's mandate and obligations to it beneficiaries.

I Liheslatura finds that this Lot No. 7 NEW, Block No. 1, Tract 1427, had it not been transferred to the Airport for the specific purpose of industrial development as part of the Airport Industrial Park it would have been subsequently transferred to the Trust for its use. *I Liheslatura* finds that the operation and commission of a lease to a restaurant facility for which the Airport does not have any direct relation to its operations and thus is not needed by the Airport to meet its mandate.

Therefore, *I Liheslatura* intends to transfer the property and lease of the restaurant facility from the Airport whose services are not directly related to its operations to the Trust, in order to support the development of basic infrastructure of the Trust properties to make them habitable.

Section 2. Transfer of Title. Title to and jurisdiction over the parcel of real 21 property Lot No. NEW, Block No. 1, Tract 1427 containing an area of 4,091 ± 22 square meters presently under lease for the operations of a restaurant facility is 23 hereby transferred from the Guam International Airport Authority to the Chamorro 24 25 Land Trust Commission which *shall* act as sole administrator of the lease to this 26 parcel and shall receive all payments thereunder. All other terms of the lease agreement executed prior to January 17, 2011 (the "Lease") between the lessee and 27 the Airport shall remain in effect, except that references to the Guam International 28 Airport Authority shall be deemed to refer to the Chamorro Land Trust 29 Commission. 30

Section 3. Effective Date. This Act *shall* take effect upon enactment.

32 Section 4. Severability. If any provision of this Law or its application to any 33 person or circumstances is found to be invalid or contrary to law, such invalidity 34 *shall not* affect other provisions or applications of this Law which can be given 35 effect without the invalid provisions or application and to this end the provisions of 36 this Act are severable.
