#### Comment to Bill No. 137-32 (COR)

Bill 137-32 (COR) is an act to add a new §1115 to Chapter 1 of Title 12 of the Guam Code Annotated; relative to providing no cost space to the Guam Customs and Quarantine Agency in a manner consistent with federal law.

The bill has a potential funding impact in terms of savings from expenditure of rental cost at the airport incurred by the Customs and Quarantine Agency (CQA). As of to date, CQA is paying monthly space rental at the A.B. Won Pat International Airport Authority at \$5.30 per sq. ft. with the total of 31,625 sq. ft. occupied. The monthly rental cost based on the sq. ft. occupied is \$167,717.91 with an annual cost of \$2,012,614.92 to \$3,264,296.00. The FY2013 Appropriation Act (P.L. 31-233) set aside \$3,264,296.00 for the CQA's rental costs. The savings from rental costs will support Customs & Quarantine Agency's current personnel services requirements and improve other operational areas in providing, maintaining, and operating services to consumers.
