1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Section 3118 is *added* 16GCA to read:

3 **§3118. Renewal of Licenses for Off-Island Residents.** The Department may
4 accept applications for renewals of drivers licenses through mail, electronic mail or
5 online applications from residents who are off-island for extended periods of time
6 for the following reasons: (1) education, (2) employment, (3) service in the United
7 States Armed Forces, (4) medical care or (5) caring for a sick relative.

8
9 Individuals renewing drivers licenses pursuant to this section are required to
10 submit the following: (1) completed applications and affidavits required by this
11 Chapter (2) certification from a licensed physician or optometrist that the applicant
12 does not have a vision problem that will impair driving ability, or if the applicant
13 does have a vision impairment, that such impairment is correctable with corrective
14 lenses, and (3) remittance of the licensing fee and postage fee, if applicable.
