

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Naming of the Malesso Pier Park in Honor of the Veterans**
3 **of Malesso who have served in the U. S. Armed Forces.**

4 A new §849.5.1 is hereby added to Article 1, Chapter 8, of Title 1,
5 Guam Code Annotated, pertaining to the official naming of the Malesso Pier Park,
6 which shall as follows:

7 “§849.5.1. *Plásan Beteránon Mansendálon Malesso’ (Veteran Sons*
8 **and Daughters of Malesso Park).**”

9 The Malesso Pier Park, located within the municipality of Malesso,
10 Guam, shall heretofore be referred to as the *Plásan Beteránon Mansendálon*
11 *Malesso’ (Veteran Sons and Daughters of Malesso Park)*, in honor and
12 recognition of the men and women of Malesso who have selflessly served in the U.
13 S. Armed Forces, and as an extended acknowledgement of the veterans of Guam

1 who have devotedly served the people of Malesso, the people of Guam, and the
2 people of United States of America in defense of freedom.

3 The Malesso Municipal Planning Council (the “Council”) of the Malesso
4 Mayor’s Office shall be responsible for the construction of an appropriate signage
5 designating such park facility as the *Plåsan Beterånon Mansendålon Malesso’*
6 *(Veteran Sons and Daughters of Malesso Park)*. The Council *shall* be authorized
7 to receive contributions, both cash and/or in-kind, and conduct fundraisers to fund
8 the construction, beautification and maintenance of the *Plåsan Beterånon*
9 *Mansendålon Malesso’ (Veteran Sons and Daughters of Malesso Park)*.”

10 **Section 2. Effective Date.**

11 The provisions contained herein shall be effective upon enactment of
12 this Act.
