P.L. 32-060, in part, references the addition of §§ 5201 to 5205 to Title 11 GCA. According to footnotes provided by the Compiler of Law in Ch. 5, 11 GCA, the title *Gaming* was repealed and enacted as a new Chapter 5 (entitled *Dog Racing*). The Bureau notes potential loss of revenues that would have been otherwise allocated to the Guam Memorial Hospital (GMH) from the Guam Healthcare Trust Development Fund. Should Bill 149-32 pass into law, GMH would lose up to 60% for operations and start up capital for an Urgent Healthcare Center and up to 40% for Medicaid program, debt service payment and medication/supplies. The Bureau has contacted the Department of Revenue and Taxation; however, data has not been received as of these comments.

AN ACT TO REPEAL PUBLIC LAW 32-060.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan*
3 finds that the people of Guam have spoken resoundingly about their desire
4 for a veto of Bill 19 and that their voices were disregarded when the Bill
5 was allowed to lapse into law, becoming Public Law 32-060.

6 *I Liheslatura* further finds that the greatest demonstration of
7 leadership is a willingness to respond to the call of our people, and to take
8 all necessary measures to produce an outcome that they seek. The highest
9 form of leadership is further defined in a willingness to accept mistakes,
10 and to thereafter take action to correct those errors to the satisfaction of our
11 community.

12 *I Liheslatura* additionally finds that the community desires to keep
13 community activities that benefit our *manamko'*, veterans, sports teams,
14 cockfighters, and non-profit organizations, and further desire to have the

1 question of the legality of gaming machines resolved in the courts through
2 the Attorney General.

3 It is therefore the intent of *I Liheslaturan Guåhan* to repeal Public Law
4 32-060.

5 **Section 2. Repeal of Public Law 32-060.** Public Law 32-060 is hereby
6 *repealed.*
