Is there a federal mandate to establish the program/agency?

Footnotes: The proposed legislation is seeking to waive the issuance fees of gold star license plates to immediate family members of Guam's fallen heroes. This waiver only applies to family members certified for eligibility by the Guam Veterans Affairs Office. The potential maximum fiscal impact is approximately \$31K based on the following assumptions:

• There are approximately 125 fallen heroes from World War II to the present conflict in Afghanistan.

• There are approximately 5 members per family household.

• The issuance fee for a gold star license plate is \$50

It is assumed that all immediate family members applied and received the waiver of the issuance fees.

The waiver is an one-time benefits. The fiscal impact is negligible.
