

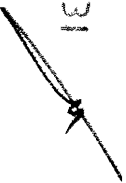

Assumptions

- 1) a 10-yr period baseline is used
- 2) fee cost per year for a 5-yr license is \$9.00
- 3) fee cost per year for a 6-yr license is \$8.33
- 3) 50,000 licenses are renewed every 5 years

Based on these assumptions, the implementation of the proposed rate of \$50 for a 6-yr term would result in a reduction of approximately \$333K at year 10 or \$500K at year 15 to the Territorial Highway Fund.



1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 Guam law recently allowed drivers to renew their operator licenses for a period of
4 either three (3) or five (5) years. In order to even further alleviate delays and provide
5 improve service for the customers at the Department of Revenue and Taxation Motor
6 Vehicle Division, it is the intent of *I Liheslaturan Guåhan* to amend §3102 of Chapter
7 3, Title 16 Guam Code Annotated relative to the renewal of driver's licenses.

8 **Section 2.** §3102 of Chapter 3, Title 16 Guam Code Annotated is hereby
9 *amended* to read:

10 “**§3102. Same: Fees.** The following fee schedule in items (a) through (h)
11 is valid for a three (3) year period. The applicant may elect for a license,
12 notwithstanding §3101(m), Chapter 3, Title 16 GCA, which shall be valid for a
13 ~~five (5)~~ six (6) year period, provided that, the fee for such a license shall be
14 ~~Forty five Dollars (\$45.00)~~ fifty dollars (\$50.00). The fee for the issuance of a
15 motor vehicle driver's license is as follows:

1 An instruction permit shall not be issued for a period to exceed ninety
2 (90) days. A temporary permit shall not be issued for a period to exceed thirty
3 (30) days.”

4 **Section 3. Effective Date.** This act shall be effective immediately upon
5 enactment.

6 **Section 4. Severability.** *If* any provision of this Law or its application to any
7 person or circumstance is found to be invalid or contrary to law, such invalidity shall
8 *not* affect other provisions or applications of this Law which can be given effect
9 without the invalid provisions or application, and to this end the provisions of this
10 Law are severable.
