

**AN ACT TO ELIMINATE THE SETTING OF SENATORS'
SALARIES AS A PERCENTAGE OF THE SALARY PAID TO
THE JUDGES OF THE SUPERIOR COURT OF GUAM**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. 2 GCA § 1106 (a) is amended to read:**

3 “(a) Compensation of each member of *I Liheslaturan Guåhan* [the Guam Legislature] shall
4 be paid in twenty-six (26) equal installments at the rate per annum of ~~fifty percent (50%)~~ of the
5 annual salary of a judge of the Superior Court; the compensation of the Speaker of *I Liheslaturan*
6 *Guåhan* shall be paid in twenty six (26) equal installments at the rate per annum of fifty percent
7 (50%) of the annual salary of the presiding judge of the Superior Court. ~~Such compensation shall~~
8 ~~be paid out of funds to be appropriated to *I Liheslaturan Guåhan* [the Guam Legislature].~~ Sixty
9 Thousand Eight Hundred Forty Dollars (\$60,840.00); the compensation of the Speaker of *I*
10 *Liheslaturan Guåhan* [the Guam Legislature] shall be paid in twenty-six (26) equal installments at
11 the rate per annum of Sixty-seven Thousand Six Hundred Dollars (\$67,600.00). Such
12 compensation shall be paid out of funds to be appropriated to *I Liheslaturan Guåhan* [the Guam
13 Legislature].”
