#### AN ACT TO ELIMINATE THE SETTING OF SENATORS' SALARIES AS A PERCENTAGE OF THE SALARY PAID TO THE JUDGES OF THE SUPERIOR COURT OF GUAM

#### **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

#### Section 1. 2 GCA § 1106 (a) is amended to read:

3 "(a) Compensation of each member of I Liheslaturan Guåhan [the Guam Legislature] shall be paid in twenty-six (26) equal installments at the rate per annum of-fifty percent (50%) of the 4 5 annual salary of a judge of the Superior Court; the compensation of the Speaker of I Liheslaturan Guåhan shall be paid in twenty-six (26) equal installments at the rate per annum of fifty percent 6 7 (50%) of the annual salary of the presiding judge of the Superior Court. Such compensation shall 8 be paid out of funds to be appropriated to *I Liheslaturan Guåhan* [the Guam Legislature]. Sixty 9 Thousand Eight Hundred Forty Dollars (\$60,840.00); the compensation of the Speaker of I Liheslaturan Guåhan [the Guam Legislature] shall be paid in twenty-six (26) equal installments at 10 11 the rate per annum of Sixty-seven Thousand Six Hundred Dollars (\$67,600.00). Such 12 compensation *shall* be paid out of funds to be appropriated to *I Liheslaturan Guåhan* [the Guam Legislature]. " 13
