For an additional Guam holiday, the *Guam History and Chamorro Heritage Day*, the Government's total estimated cost for personnel services of departments/agencies paid through the Department of Administration, for one day is \$810,147 (General Fund: Salaries - \$401,087 / Benefits - \$144,327; Special Fund: Salaries - \$97,900 / Benefits - \$37,162; Federal Fund: Salaries - \$93,974 / Benefits - \$35,597) based on Labor for pay period ending March 8, 2014. Additional costs will be incurred by employees required to work on the proposed holiday, such as uniform personnel (safety and health) and others, who will be compensated at a rate equivalent to double their rate. It is noted that the bill language identifies \$1001 of 1 GCA, however, the listing of holidays of Guam are under \$1000.

AN ACT TO AMEND §1001 OF 1GCA RELATIVE TO ESTABLISHING GUAM HISTORY AND CHAMORRO HERITAGE DAY AS A LEGAL HOLIDAY OF THE GOVERNMENT OF GUAM.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 1001 of 1GCA is *amended* to read as follows:

3 §1000. Holidays.

- 4 (a) The holidays of Guam are:
- 5 New Year's Day;
- 6 Martin Luther King, Jr. Day, the third Monday in January:
- 7 Guam History and Chamorro Heritage Day, the first Monday in March:
- 8 Memorial Day, the last Monday in May;
- 9 Independence Day, July 4th;
- 10 Liberation Day, July 21st;
- 11 Labor Day, the first Monday in September;
- 12 All Souls' Day, November 2;
- 13 Veterans' Day, November 11;
- 14 Thanksgiving, the fourth Thursday in November;
- 15 Our Lady of Camarin Day, December 8; and
- 16 Christmas, December 25th.

(b) Whenever a holiday listed in Subsection (a) of this Section falls on a Saturday or
 Sunday, the government of Guam shall follow the Federal government's practice for that
 holiday.

4 (c) In addition to the holidays specified in Subsection (a) of this Section, *I Maga'lahen*5 *Guåhan* may declare by Executive Order additional non-permanent holidays for special
6 purposes. No holiday declared by Executive Order shall be continued beyond the year in
7 which the Executive Order is issued.

8 (d) Notwithstanding any other provision of law, no Government of Guam employee
9 shall be entitled to holiday pay for working on *Guam History and Chamorro Heritage Day*.
10 Government of Guam employees required to work on *Guam History and Chamorro Heritage*

11 Day shall be given one (1) day off, at the employee's option, during the two-week prior to or

12 after Guam History and Chamorro Heritage Day.
