The Bureau requests that Bill No. 329-32 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 329-32(COR) is an Act to rezone Lot No. 2-1 New, Tract 132, in the municipality of Agat, from a One-Family Dwelling Zone (R1) to a Commercial Zone (C).

The Bill proposes that the specified lot be rezoned so that the Episcopal Church in Micronesia can resume providing its services in Southern Guam after relocating to Upper Tumon due to being notified that their Church's activities were not in compliance with its zoning designation.

Per the Department of Revenue & Taxation, the land tax rate and the building tax rate would remain the same regardless of the change to any property's zoning. Per the Department of Land Management, zone changes done through legislation are not charged any fees in regards to zone change amendments or certification of zoning fees. There is no component of the Bill that requires an act to make any changes to the property's existing infrastructure.

The intent of the Bill poses no fiscal impact upon any funds of the Government of Guam.

### I MINA' TRENTAI DOS NA LIHESLATURAN GUÅHAN 2014 (SECOND) Regular Session

AN ACT TO *REZONE* LOT NO. 2-1 NEW, TRACT 132, MUNICIPALITY OF AGAT, FROM ONE-FAMILY DWELLING ZONE (R1) TO COMMERCIAL ZONE (C).

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

Legislative Findings and Intent. The Episcopal Church in Micronesia has been offering worship services and related activities at its St. Andrews Church location in Agat since 1972. In March of 2013 the church was made aware that its activities were not in compliance with its zoning designation of Single Family-Dwelling (R1) and closed its doors to avoid any fines and penalties that may accrue. The congregation of St. Andrews has since joined the congregation of its brother church St. John's the Divine Episcopal Church to attend worship services at its location in Upper Tumon. St. Andrews Church continues to hold title to its location in Agat and would like to return to Southern Guam to provide services to its congregation members residing in Agat and the surrounding vicinity, and to be an option for active duty personnel and their dependents seeking worship services. The conduct of these activities would be more appropriate if the location is rezoned, so it is the intent of I Liheslaturan Guåhan to accommodate the Church's desire to offer worship services at its Agat location by re-zoning the lot from One Family-Dwelling (R1) to Commercial (C).

Section 2. Lot rezoned. Notwithstanding any other provision of law, Lot 2-1 NEW, Tract 132, Municipality of Agat, containing an area of 2203.78+/- square meters, is hereby rezoned from One-Family Dwelling Zone (R1) to Commercial Zone (C).

Effective Date. This Act shall take effect upon enactment. Section 3.
