The bill seeks to require the Guam Board of Medical Examiners (GBME) to publish, via its website, a listing of licenses issued to include the license holder's name, primary work address, phone number, specialty, initial date of licensure, license status and board certifications. See attached Comments.

### COMMENTS TO BILL 331-32(LS)

BILL NO. 331-32 (LS) IS AN ACT TO ADD A NEW § 10315 TO CHAPTER 10, TITLE 5 OF THE GUAM CODE ANNOTATED (GCA); RELATIVE TO THE ONLINE AND PUBLIC DISCLOSURE OF MEDICAL LICENSES ISSUED BY THE GUAM BOARD OF MEDICAL EXAMINERS (GBME).

Section 1 of the bill proposes to establish a special requirement to be imposed whereby the GBME will be mandated to publish and update quarterly on the GBME website a listing of licenses issued pursuant to Chapter 12, Article 2, Title 10 of the GCA, "Physicians Practice Act, to include the:

- 1) License holder's name
- 2) Primary work address
- 3) Phone number
- 4) Specialty
- 5) Initial date of licensure
- 6) License status
- 7) Board certifications

According to information received from Department of Public Health and Social Service (DPHSS) on May 21, 2014, the GBME does not currently have their own dedicated website. Rather, DPHSS has established and maintained an existing listing of current medical licenses on the DPHSS website at: <u>http://www.dphss.guam.gov/document/gbme-renewal-listing-2013</u>. Additionally, DPHSS states that to establish a physician online management system for the GBME will cost an estimated \$165,000.

In summary, the overall intent of this bill is to mandate the GBME to maintain a list, per the specific requirements outlined in the bill, to establish, maintain and update a listing of current medical licenses. The Health Professional Licensing Fund collects an average of \$181,800 annually and is a revolving fund. An estimated \$165,000 would be necessary just to establish such a system. To be in compliance with such legislation would incur a significant fiscal impact to the GBME's Health Professional Licensing Fund which would include any additional costs for the expected and subsequent maintenance of an exclusively established website for the GBME.

# AN ACT TO ADD A NEW § 10315 TO CHAPTER 10, TITLE 5 OF THE GUAM CODE ANNOTATED; RELATIVE TO THE ONLINE AND PUBLIC DISCLOSURE OF MEDICAL LICENCES ISSUED BY THE GUAM BOARD OF MEDICAL EXAMINERS.

**BE IT ENACTED BY THE PEOPLE OF GUAM:** 

Section 1. A new § 10315 is hereby *added* to 5 GCA Chapter 10 to
read as follows:

4	"§ 10315. Special Requirement for Medical Licenses.
5	Within six (6) calendar months of the enactment hereof, the
6	Guam Board of Medical Examiners shall publish and update on a
7	quarterly basis on its website a listing of licenses issued pursuant to
8	Chapter 12, Article2, Title 10 of the Guam Code Annotated (Physicians
9	Practice Act), including the license holder's name, primary work
10	address, phone number, specialty, initial date of licensure, license
11	status, and board certifications."

12 Section 2. Enactment. This Act is effective upon enactment.
