

The Bureau requests that Bill No. 341-32 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 341-32(COR) is an Act to rezone Lot No. 14 New, Block No. 16, in the municipality of Dededo, from a Multiple-Family Dwelling Zone (R2) to a Commercial Zone (C).

Per the Department of Revenue & Taxation, the land and building tax rates remain the same regardless of the change to any property's zoning. Per the Department of Land Management, zone changes done through legislation are not charged any fees in regards to zone change amendments or certification of zoning fees. There is no component of the Bill that requires an act to make any changes to the property's existing infrastructure.

The intent of the Bill poses no fiscal impact upon any funds of the Government of Guam.
