Comments:

1/ Should this proposed legislation become law, there is a potential of revenues generated in the form of building permits and real property taxes through the proposed zone changes of Lot Nos. 2247-REM, 2242-R1, 2244-R2, 2247 Eastern Part-R1, and 2247-PART-R1 from Agricultural Zones (A) to Multiple Dwelling Zones (R2). The zone changes could offer the potential of additional revenues in future developments to include housing complexes, health clinics, utilities and public facilities, and air, bus, taxi, auto, rental terminals. This would require building permits to construct such facilities. The Lots represent a combined area consisting of 109,604 square meters or 27 acres. If housing developments or other buildings are constructed on these Lot Nos., there is also a potential for revenues generated through real property taxes. Assuming that a three story apartment building was to be built with an estimated gross square feet count at 13,300 sq. ft., the Department of Public Works anticipates \$975,000 - \$1,040,000 of revenues generated. Per Revenue and Taxation, the appraised value of this apartment building would be \$1,064,000. This would impose a building tax rate (0.00388) of \$4,128.32 and a land tax rate (0.000875033) of \$931.04. With the given information, the Bureau estimates that \$5,059.36 will be received by the Department of Revenue and Taxation in additional real property taxes.


