Footnotes:

The proposed amendment in Bill No. 387-32(COR) is to increase the appropriation by another \$60,000 or from \$206,550 to \$266,550 for the purpose of complying with Public Law 32-134 to provide for a binding referendum during the 2014 General Election to determine the medical use of cannabis. Per recent discussion with the Executive Director of the GEC, she mentioned that the \$60,000 will be used for ads and mailing of pamphlets for the legislative submitted referendum in line with P.L. 32-134. In addition, please note that the intended amendment is added to Bill No. 269-32(LS), as substituted, under Section 32, Chapter XII, Miscellaneous provisions.



1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 2 of Public Law 32-169 is hereby *amended* to
3 read:

4 “Section 2. Appropriation. Notwithstanding any other provision of law,
5 the sum of Two Hundred ~~Six~~ Sixty-six Thousand Five Hundred Fifty
6 Dollars (~~\$206,550~~) (\$266,550) is hereby appropriated from Fiscal Year
7 2014 revenues to the Guam Election Commission for the purchase of the
8 following:

9 (a) the sum of One Hundred Thirty Four Thousand Two
10 Hundred Fifty Dollars (\$134,250) shall be allocated from the
11 appropriation in this Section for the purchase of a central count

1 voting system with software and professional services, utilizing
2 three (3) ballot tabulators;

3 (b) the sum of Forty Eight Thousand Five Hundred Dollars
4 (\$48,500) shall be allocated from the appropriation in this Section
5 for the purchase of ballot stock and coding services; ~~and~~

6 (c) the sum of Twenty Three Thousand Eight Hundred Dollars
7 (\$23,800) shall be allocated from the appropriation in this Section
8 for the sole purpose of the payment by the Guam Election
9 Commission to the University of Guam for its use of the University
10 of Guam Field House during the 2012 Primary and General
11 Elections as an Election Return Center; and

12 (d) the sum of Sixty Thousand Dollars (\$60,000) shall be
13 allocated from the appropriation for the purpose of complying
14 with Public Law 32-134.

15 (e) ~~(d)~~The appropriation in this Section shall not lapse and shall
16 remain available 20 pursuant to this Act until fully expended. §
17 1303 of Chapter I, Article 3, Title 5, 21 Guam Code Annotated, shall
18 not apply to the appropriation or allocations in this Section. “

19 **Section 3. Effective Date.** The provisions contained herein shall be
20 effective upon enactment of this Act.
