COMMENTS TO BILL 39-32(COR)

BILL NO. 39-32 IS AN ACT TO *AMEND* §3103 OF CHAPTER 3
TITLE 7, OF THE GUAM CODE ANNOTATED RELATIVE TO ADDING
ADDING A SUCCESSIVE TERM OF SERVICE FOR THE CHIEF JUSTICE
OF THE SUPREME COURT OF GUAM.

The Bill is proposing to change the term of service for the Chief Justice of the Supreme Court of Guam to a maximum of two (2) successive terms and may not be eligible to hold that position until one (1) full term has intervened. Currently, a term is for a three-year period. If passed and becomes Public Law, a Chief Justice may serve up to six (6) consecutive years.

There is no added fiscal impact other than the adjustment in Base pay of the Chief Justice compared to that of a full-time Justice. The annual salary of the Chief Justice is \$138,200 and the annual Salary of a full-time Justice is \$136,200. This variance of the \$2,000 is netted out when the Chief Justice term expires, becoming a full-time Justice of the Supreme Court, while the selection of a Chief Justice from the other full-time Supreme Justices continues.
