1 BE IT ENACTED BY THE PEOPLE OF GUAM:

3 Section 1. Paragraph (14) of §3101(f) of Chapter 3 of 16GCA is *amended*
4 to read:

5 (14) ~~License Limitation on Engine Size. A licensee is prohibited~~
6 ~~from operating a motorcycle/motorbike on public roads with an engine~~
7 ~~larger than the engine in the motorcycle/motorbike for which he/she used to~~
8 ~~take the road exam. Licensees may qualify to operate larger~~
9 ~~motorcycles/motorbikes by passing a qualifying road exam. This provision~~
10 ~~shall be effective for licenses issued to first-time licensees after January 1,~~
11 ~~2015. No person may use a moped, scooter or a motorcycle/motorbike with~~
12 ~~an engine size of One Hundred Fifty cubic centimeters (150 cc) or smaller to~~
13 ~~take a qualifying road exam.~~
