Comments on Bill No. 396-32 (COR)

Bill No. 396-32 proposes to fund the payment of increments owed to the Guam Memorial Hospital employees from the period 10/1/2012 to 07/17/2013 (Fiscal Year 2013). Section 2 of Bill No. 396-32 amends Section 1, Chapter XV of Public Law 32-181 (General Appropriations Act of 2015) by reducing the amount appropriated to the Classified Vacancies for Executive Branch Agencies and Departments Cost Pool Account, from \$3,077,971 to \$1,578,471. The reduction in appropriation of \$1,499,500 was re-appropriated in Section 1 of the proposed legislation to the Guam Memorial Hospital Authority to fund the payment of increments. It should be noted that input from the Guam Memorial Hospital Authority has not been received at the writing of these comments to ascertain whether the \$1,499,500 amount provided in said bill, would be sufficient in making whole the obligations to the employees.

Public Law 32-181; Chapter XV; Section 1 stipulated that all appropriations to the Classified Vacancies for Executive Branch Agencies and Departments Cost Pool Account shall only be used to pay salaries of new hires for classified full-time employee positions unfilled at the beginning of FY 2015, and for positions filled prior to the enactment of the General Appropriations Act of 2015, within the BBMR, DOA, DRT, DOL, AGR, GBHWC, and/or DPR. The proposed amendment which entails a reduction in funding of \$1,499,500 and commits only \$1,578,471 to the Classified Vacancies for Executive Branch Agencies and Departments Cost Pool Account, will negatively impact on the aforementioned department's ability to pay personnel services requirements for vacant positions filled prior to the start of Fiscal Year 2015 and to fill vacant positions that are essential to the collection of revenues, vital to government operations and are ordered by the Courts.

BE IT ENACTED BY THE PEOPLE OF GUAM: 1

- Section 1. Increments for GMH Employees. The sum of One Million Four 2

- Section 3. Severability. If any provision of this Act or its application to any

- 9 **Section 4. Effective Date.** This Act *shall* become immediately effective upon enactment.
