## Notes:

The proposed legislation intends to add a new Subsection (Y) to § 87104 of Chapter 87, Title 5 of the Guam Code Aunotated which would provide the Department of Chamorro Affairs the authority to establish interim admission, event, and membership fees for the Guam Museum. The Department has yet to determine or finalize these base rates but has acknowledged that legislation will provide revenue to help sustain the new Guam Museum. The current estimated operating costs for the Museum is approximately \$1.2 Million per annum and is being supported by various fund sources (TAF, GF, etc.). Any fees that are collected should be applied to offset the costs of the operations of the facility.
