

The Bureau requests that Bill No(s) 302-33 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 302-33 (COR) is an act to add a new § 849.12 to Article 1 of Chapter 8, Title 1, Guam Code Annotated, relative to naming the thirty four (34) Festival of Pacific Arts Village Houses “Lugåt I Manma Ñaina-ta” and each house individually after heroes and leaders of the Chamorro-Spanish War.

The intent of the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
