



The Bureau requests that Bill No(s). 347-33 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

The Bill is an Act to repeal and re-enact § 51302 of Article 3 of Chapter 51 of Title 10, Guam Code Annotated relative to the Recycling Revolving Fund. The Recycling Revolving Fund shall be maintained as a separate account and not to be commingled with the General Fund, and shall be expended exclusively for purposes authorized in Article 3 of Chapter 51 of Title 10, Guam Code Annotated.

The intent is administrative in nature as submitted for legislative consideration, and does not impact any government funds of the Government of Guam.
