### Bureau of Budget & Management Research Attachment to Fiscal Note No. 373-33 (COR)

#### **Comments**

Per the Office of the Attorney General (OAG), the fiscal impact will be minimal as they handle these types of cases. The legislation would include a new chargeable offense under the family violence statute. The fiscal impact may be basically with the Criminal Injuries Compensation Commission Fund since the victims of this new chargable offense would be qualified to apply for compensation. Also, the Attorney General has noted there may be a fiscal impact with the Restitution Court with OAG's attorneys if an issue of restitution is involved.
