# BUREAU OF BUDGET AND MANAGEMENT RESEARCH COMMENTS ON BILL NO. 93-33 (LS)

The intent of the proposed legislation is to reserve, in perpetuity, the Crown Lands portion of "Lot Apra Harbor Reservation B-5" (Returned Federal Excess Lands) for the future expansion of the Guam U.S. Veterans' Memorial Cemetery.

The proposed legislation stipulates that the existing Guam U.S. Veterans Cemetery will reach maximum burial capacity in about 15 years. Reservation of the subject property will ensure adequate burial space for our Veterans and the preservation of the integrity of a single Cemetery.

Section 3 of the proposed legislation dubs the Department of Land Management (DLM) as responsible for conducting the survey and severance of the Crown Lands portion of Lot B-5 to be used for the Cemetery expansion. Per the DLM Director, utilizing professional services to conduct the subject survey would cost an estimated \$30,000.

The DLM Director has stressed that the subject property known as the Crown Lands are determined to be private lands. For the government to take ownership of private property, two qualifications must be met. First, the intent must be for the lawful good of the public. Second, the owners must be compensated appropriately. The proposed transfer meets the first requirement of intended good of the public, but there is no stipulation of compensation to the property owners, the value of which is determined using the average of two appraisals. Because the subject property has yet to be appraised, the cost of appropriate compensation cannot be determined at this time.
