1 BE IT ENACTED BY THE PEOPLE OF GUAM:

3 **Section 1.** Section 1001 of 1GCA is *amended* to read as follows:

5 **§1000. Holidays.**

- 6 (a) The holidays of Guam are:
- 7 New Year's Day;
 - 8 Martin Luther King, Jr. Day, the third Monday in January;
 - 9 Guam Discovery Day, the first Monday in March;
 - 10 Memorial Day, the last Monday in May;
 - 11 Independence Day, July 4th;
 - 12 Liberation Day, July 21st;
 - 13 Labor Day, the first Monday in September;
 - 14 All Souls' Day, November 2;
 - 15 Veterans' Day, November 11;
 - 16 Thanksgiving, the fourth Thursday in November;
 - 17 Our Lady of Camarin Day, December 8; and

1 Christmas, December 25th.

2 (b) Whenever a holiday listed in Subsection (a) of this Section falls on a
3 Saturday or Sunday, the government of Guam shall follow the Federal government's
4 practice for that holiday.

5 (c) In addition to the holidays specified in Subsection (a) of this Section, *I*
6 *Maga'lahaen Guåhan* may declare by Executive Order additional non-permanent
7 holidays for special purposes. No holiday declared by Executive Order shall be
8 continued beyond the year in which the Executive Order is issued.

9 (d) Notwithstanding any other provision of law, no Government of Guam
10 employee shall be entitled to holiday pay for working on *Discovery Day*. Government
11 of Guam employees required to work on *Discovery Day* shall be given one (1) day off,
12 at the employee's option, during the two-week prior to or after *Discovery Day*.
