

AN ACT TO ADD A NEW SUBSECTION §4104.2 TO §4104 OF CHAPTER 4, TITLE 4, GUAM CODE ANNOTATED RELATIVE TO THE PROOF OF ELIGIBILITY FOR VETERANS PREFERENCE CREDIT.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A *new* subsection §4104.2 is hereby *added* to §4104 of Chapter 4, Title 4 of Guam Code Annotated to read:

4 "4104.2 Proof of Eligibility for Veteran's Preference
5 Credit. Persons claiming veteran's status must submit their DD
6 Form 214, Armed Forces of the United States Report of Transfer or
7 Discharge. A person must have completed at least 180 cumulative
8 days of service in the Armed Forces of the United States and must
9 have received other than a dishonorable discharge from such
10 service to be eligible for veteran's preference."

**Section 2. Effective Date.** This Act shall become immediately effective upon enactment.

**Section 3. Severability.** If any of the provisions of this Act or the application thereof to any person or circumstance is held invalid, such invalidity shall *not* affect any other provision or application of this Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
