AN ACT TO REZONE LOT NO. 14NEW, BLOCK NO. 16 IN THE MUNICIPALITY OF DEDEDO FROM MULTI-FAMILY DWELLING (R-2) TO COMMERCIAL (C).

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Notwithstanding any other provision of law, the following lots as described below are hereby rezoned from Multi-Family Dwelling (R-2) to Commercial (C):

(a) Lot No. 14NEW, Block No. 16, in the municipality of Dededo, containing an area of 1,188 square meters, referenced to map filed under Document No. 100379, C.T. No. 77567;

Section 2. Effective Date. This provision contained herein shall take effect immediately upon enactment of this Act.

Section 3. Severability. *If* any provision of this Act or its application to any person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this Act which can be given effect without the invalid provision or application and to this end the provisions of this Act is severable.
